CONTENTS Contains Diallyldimethyl Ammonium Chloride 9.2% ww (92G/LT)

WHEN TO USE All year round. Results may be affected if rain falls within 48 hours and at temperatures below 8°C. Avoid spraying during a heatwave.

WHERE TO USE On all surfaces susceptible to contamination by algae, lichen or mosses. Di-Ard is not intended for treating moss on lawns, flower beds or algae treatment in pond water.

PRIMARY TREATMENT Dilute 1 litre of product with 10 litres of water. Apply at a rate of 1 litre of diluted product per 5m² of surface area.

SECONDARY TREATMENT Dilute 1 litre of product with 12-20 litres of water. Apply at a rate of 1 litre of diluted product per 5m² of surface area.

1 Litre: 1:10 dilution covers 50 sqm, 1:20 dilution covers 100 sqm.

5 Litres: 5:50 dilution covers 250 sqm, 5:100 dilution covers 500 sqm.

25 Litres: 25:250 dilution covers 1250 sqm, 25:500 dilution covers 2500 sqm.

SAFETY PRECAUTIONS

Causes skin irritation. Causes eye irritation. Keep out of the reach of children. Wash hands thoroughly after handling. Wear protective gloves, eye protection and face protection. IF SWALLOWED: Call a POISON CENTRE or doctor / physician if you feel unwell. If medical advice is needed, have product container or label at hand. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do – continue rinsing. Keep container tightly closed. Keep only in original container.

STATUTORY CONDITIONS RELATING TO USE

The Control of Substances Hazardous to Health Regulations 1999 may apply to this product at work.
